Happy Windy March, Grace!

From the keyboard of the editor

Here is a prayer resource that I found and would like to share.

A reading from Mark 4:35-41 “The Calming of a Storm at

Sea.”

“On that day, as evening drew on, he said to them, “Let us cross to the other side.” Leaving the crowd, they took him with them in the boat just as he was. And other boats were with him. A violent squall came up and waves were breaking over the boat, so that it was already filling up. Jesus was in the stern, asleep on a cushion. They woke him and said to him, “Teacher, do you not care that we are perishing?” He woke up, rebuked the wind, and said to the sea, “Quiet! Be still!” The wind ceased and there was great calm. Then he asked them, “Why are you terrified? Do you not yet have faith?” They were filled with great awe and said to one another, “Who then is this whom even wind and sea obey?” (NABRE)

Commentary: A lesser wind, like the one stirring up the health care landscape, can blow out the debris, the cobwebs. New payment and patient care models spur us to embrace new ways of doing what we’ve always done: bring the healing presence of Christ to the people we serve.

When you were a kid, did you ever go outdoors on a windy day with an umbrella?
Try to be Mary Poppins?

But when you’re a grown up, being in the wind isn’t so much fun. It messes up your hair. Makes driving a little harder. And in a really strong wind it’s even hard to walk.

What might happen if we were to reframe how we see the winds of change? Instead of seeing the wind as something to resist, what if we approach the wind with curiosity and playfulness of a child? How can we make the wind work FOR us? FOR our patients and clients?

The Indian poet Rishika Jain said, “When the Winds of Change Blow, Some people build Walls -While Others Build Windmills.... Remember we cannot change the direction of the Wind, but we can always adjust our sails....”

Let us pray.

Father in Heaven, sometimes we feel like the disciples in the boat on the Sea of Galilee, tossed about by the stormy winds.

- Overwhelmed trying to keep up with the day to day demands of the job. - Stressed out trying to meet budget.
- Frustrated with the Leadership Scorecard.
- Juggling home and personal needs with work.

Then we look up and see Jesus striding across the water. He beckons us to move from the achievements of the past, from the uncertainties of the present, into a future filled with possibilities. Help us to step out in faith confident that You are the one whom the wind and the sea obey.

Empower us to transform our ministry and world that we may continue to fulfill our mission of Christian healing for years to come. In Your Holy Name we pray. AMEN”

This meditation spoke to me in several ways this week. A friend of mine has struggled with student loan debts for umpteen years. She looked forward to the Biden bill remitting some of the debt students owed. But, as you know, the Supreme Court currently has that case before it because some states are calling it unconstitutional, unfair, etc. The bill would aid the underprivileged who try to “catch up” by getting a college education.

Back to my story. A friend encouraged her to seek remittance as a public servant (teachers, medical personnel, other public servants are eligible), but she failed to move forward on the application for years. Recently a friend kept encouraging her to send in the application and she finally did. Not long ago, she received a letter cancelling the entire debt. She was so startled that she called the agency to make sure that everything she owed was cancelled. It was ...and all she could do was thank God for His messenger and His mercy.

As I think about the Lenten Season that we are in, isn't that what God does for all believers? How wonderful to get a letter from Him saying “The wind has changed. You no longer face eternal condemnation. Your debt is paid in full by the blood of Jesus”. THANK YOU, LORD!

The other thing that cracked me up regarding winds of change came through my soon-to-be-two year old grandson, Johnny. Many of you saw him walk with Pastor down the aisle on Sunday. His mother and I expected him to be yelling his head off, but we were very wrong. As he approaches the “Terrible Two's” Johnny has a new way of letting us know that he doesn't want to do something we ask him to do. His new phrase is “Bye-bye. See you.” as he walks the other way. I fully expected Pastor to get a “Bye-Bye. See you.” He didn't get one on Sunday, but, boy, did he get one on Monday when he stopped by to give Johnny his first baseball bat and ball. The boy wouldn't even speak to him though he came bearing gifts! Talk about the winds of change!

As we look forward to the commemoration of our Savior's death and Resurrection, we continue to know that there is no change with Him. He is our Lord and Savior, our Solid Rock on whom we can depend even when the negative winds of change blow in our lives! Enjoy the winds in this confidence, Grace.

March is Women's History Month

The Library of Congress, National Archives and Records Administration, National Endowment for the Humanities, National Gallery of Art, National Park Service, Smithsonian Institution and United States Holocaust Memorial Museum join in commemorating and encouraging the study, observance and celebration of the vital role of women in American history.

About Women's History Month

Women's History Month had its origins as a national celebration in 1981 when Congress passed Pub. L. 97-28 which authorized and requested the President to proclaim the week beginning March 7, 1982 as "Women's History Week." Throughout the next five years, Congress continued to pass joint resolutions designating a week in March as "Women's History Week." In 1987 after being petitioned by the National Women's History Project, Congress passed Pub. L. 100-9 which designated the month of March 1987 as "Women's History Month." Between 1988 and 1994, Congress passed additional resolutions requesting and authorizing the President to proclaim March of each year as Women's History Month. Since 1995, presidents have issued a series of annual proclamations designating the month of March as "Women's History Month." These proclamations celebrate the contributions women have made to the United States and recognize the specific achievements women have made over the course of American history in a variety of fields.

Executive and Legislative Documents

The Law Library of Congress has compiled guides to commemorative observations, including a comprehensive inventory of the Public Laws, Presidential Proclamations and congressional resolutions related to Women's History Month.

Child Abuse History Clearance (CY113) INFORMATION

Cost

Note: Child abuse clearance fees for volunteers will continue to be waived one time every 57 months.

How to Submit an Application

Online Submission

The Pennsylvania Child Abuse History clearance can be submitted and paid for online through the [Child Welfare Information Solution \(CWIS\) self-service portal](#). Submitting an application online allows individual applicants to receive their results through an automated system that will notify

them once their results have been processed. Applicants will be able to view and print their results online.

The self-service portal also provides organizations the ability to create business accounts to prepay for child abuse clearances and have online access to the results. Organizations who want to set up business accounts must first register for a Business Partner User account using the "Organization Account Access" link on the Child Welfare Portal. Organization accounts will allow businesses and organizations to purchase child abuse history clearance payment codes and distribute those codes to applicants. When an applicant uses a code given to them by an organization, the organization will have access to the applicant's child abuse history clearance results once those results are processed.

Paper submissions of the Pennsylvania Child Abuse History Clearance application will still be accepted for anyone who may not have access to the internet, or who may be unable to access the self-service portal due to their attempting to access the system from outside the United States.

Please note, results will be received more quickly if applied for electronically through the [self-service portal](#). Submit paper applications to:

The instructions for how to complete the Pennsylvania Child Abuse History Clearance application are now included on the last page of the application and can be printed for easy reference when completing the application. Failure to comply with the instructions that are attached to the application will cause considerable delay in processing the results.

Applicants can now type their information directly onto the application or the information can be legibly handwritten onto the application.

If the information is typed directly onto the application, the information will NOT be able to be saved on a computer unless the computer has a licensed version of the acrobat adobe software.

Therefore, please be sure to print the completed application before closing the document so that the information typed on the application is not lost.

If you have trouble accessing the application you may need to download the latest version of Adobe Reader, which is available free on the internet.

Once the application is received in the ChildLine and Abuse Registry's Verification Unit, the results of the Pennsylvania Child Abuse History Clearance will be mailed to the applicant's address that was noted on the application within 14 days from the date that the application is received in the ChildLine Verification Unit.

An applicant can request that a Pennsylvania Child Abuse History Clearance be mailed to an organization by completing a Consent Release of Information Authorization Form. Both the applicant and organization must sign the form and the form must be attached to a paper Child Abuse History Clearance application submitted via mail in order for the results to be released to the organization. Older versions of the Consent Release Form without a signature line for the organization will not be accepted and the certification result will be returned directly to the applicant, not the organization.

NOTE: Results cannot be sent to someone other than the applicant if applying for a Child Abuse History Clearance electronically via the online link above. If an organization pays the application fee, they will have the ability to access an applicant's results online if they set up a business account and provide the prepaid code to the applicant.
